



MEMORANDUM OF UNDERSTANDING (MOU) CONCERNING COOPERATION IN THE FIELD OF PHILOSOPHY AND ISLAMIC STUDIES

Between Al Mustafa International University, Iran and

Faculty of Ushuluddin and Adab (FUA), Institut Agama Islam Negeri Syekh Nurjati Cirebon, Indonesia

Al Mustafa International University Indonesia Representative herein mentioned as MIU Indonesia and Institut Agama Islam Negeri Syekh Nurjati Cirebon herein mentioned as IAIN Syekh Nurjati, Cirebon, Indonesia. Both of them hereinafter referred to as "the Parties". Pursuant to the prevailing laws and regulations in Indonesia as well as the procedure and policy of Government of Indonesia, concerning educational cooperation. Who will sign as follow:

Have agreed as follows:

Article I

Objectives

The objectives of this cooperation are to increase the quantity and quality of human resources with high moral values and characters, responsibility, academic capability, expertise, and professionalism in Islamic Studies.

Article II

Scope of Activities

The scope of activities of the cooperation shall include but not limited to:

- 1. Implementation of graduate program in the field of Islamic Studies in Faculty of Philosophy and Civilization;
- 2. Exchange of faculty members;
- 3. Exchange of students;
- 4. Exchange of publications, research materials, newsletter, etc.;
- 5. Joint projects, related to research and education.

Article III

Plan of Operation

- 1. The mechanism of cooperation shall be defined in a Program direction, which is set out in the Annex and constitutes an integral part of this Memorandum of Understanding (hereinafter referred to as "MoU")
- The detailed description of the scope of activities shall be defined in an Annual Plan of Operation. The annual Plan of Operation shall be drawn up and agreed upon by both Parties, and approved by the Ministry of Religious Affairs of the Republic of Indonesia.

Article IV

Contribution of First Party

First Party shall:

- Provide necessary funding for the execution of the obligations as specified in the program direction and annual plan of operation;
- 2. Assign qualified experts and lecturers to assist in the implementation of activities under this MoU;
- Assist in arranging necessary permits for approved Foreign lecturers and experts
 which are needed to enter and leave Indonesia whenever necessary, including
 their work and stay permits.

Article V

Contribution of Second Party

In accordance with the prevailing laws and regulations in Indonesia the Second Party shall:

 Assign qualified experts and lecturers to assist in the implementation of activities under this MoU; Assist in arranging necessary permits for approved Foreign lecturers and experts which are needed to enter and leave Indonesia whenever necessary including their work and stay permits.

Article VI

Intellectual Property Rights, Results and Publications

- Any Intellectual Rights brought by one of the Parties for the implementation of the cooperation activities under this MoU shall remain the property of that Party; however, that Party shall indemnify the intellectual property rights is not resulted from the infringement of any third Party's legitimate rights.
- 2. Further, that party shall be liable for any claim made by any third party on the ownership and legality of the use of the intellectual property right brought in by the aforementioned Party for the implementation of the cooperation activities under this MoU; Any Intellectual Property Right, data and information resulted from research activities conducted under this MoU shall be jointly owned by both Parties, and both Parties shall be allowed to use such property for non-commercial purposes free of royalty.
- 3. If intellectual property right, data and information resulted from the cooperation activities under this MoU be used for commercial purpose by on Party, the other party shall be entitled to the royalties obtained from the exploitation of such property on the basis of the principle of equitable contribution.
- 4. In such case, the object of the research activities conducted under this MoU shall constitute a part of the contribution of the Party from which the object derives. The value of the objects as part of contribution will be measured by taking into account the following factors:
 - a. If either Party wishes to disclose confidential data and information resulted from the cooperation activities under this MoU to any third party, the disclosing Party must obtain prior consent from other Party before any disclosure can be made.
 - b. All academic outcomes and products of this cooperation must follow and comply with the copy rights and intellectual property rights law in Indonesia.

Article VII

Limitation of the Personnel Activities

Al Mustafa University Representative of Indonesia ensures that its personnel engaged in the activities under this MoU, will not engage in political affairs and any commercial ventures as well as fund raising activities in Indonesia outside the cooperation program under this MoU without the prior approval of the Government of Indonesia through State Secretariat of the Republic of Indonesia.

Article VIII

Settlement of Differences

The differing viewpoint and interpretation of this MoU shall be settled amicably by mutual consultation or negotiation between both Parties.

Article IX

Amendments, Duration and Termination

- 1. Any amendment to this MoU can be made only in writing and after consultation and mutual consent of both Party;
- 2. This MoU shall be in effect from the date of its signing and be valid for the duration of 6 (six) years from the date, and can be renewed thereafter or replaced with a new MoU.
- 3. this MoU may be terminated by either Party by written notice at least 6 (six) months in advance;
- 4. In case this MoU ceases to have effect on account of termination thereof, the provisions of the Annual Plan of Operation shall be continued to apply to the extent necessary to secure the implementation of existing activities as agreed upon in the Annual Plan of Operation.
